## Northridge4x4 2021 Gladiator Jeep Giveaway Official Rules

## NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. PURCHASE OR PAYMENT DOES NOT IMPROVE YOUR CHANCE OF WINNING.

- 1. **Eligibility**: The Northridge4x4 2021 Gladiator Jeep Giveaway (the "Promotion") is open only to legal residents of the 48 United States and the District of Columbia (excluding AK and HI), Canada (excluding Quebec) (the "Territory") who have reached the legal age of majority and located in the Territory at the time of entry.
