Aingler Tek Inc. - i. Photo Entries submitted must be created by each entrant alone.
- ii. Photo Entries must be entrant's original creation; modifying, enhancing or altering a third party's preexisting work does not qualify as an entrant's original creation.
- iii. All photos must be taken using the in-app camera feature within the Aingler App.
- iv. Each photo must feature a unique fish caught by the entrant during the Promotion Period.
- v. Each fish submitted must measure at least six (6) inches in length.
- vi. Photo Entries will not be judged.

- b. **Additional Conditions of Submission:** Any Photo Entry which the Promotion Administrator or Sponsor, in their sole opinion, deem to be inappropriate for publication or inclusion in this Promotion will not be considered or displayed and the corresponding entrant will be disqualified.
