1. **Eligibility:** The Ambition Strikes Weekend Trip Sweepstakes (the "Promotion") is open only to legal residents of the 48 contiguous United States (excluding Alaska and Hawaii) and the District of Columbia (the "Territory") who have reached the legal age of majority in their state of residence, are located in the Territory at the time of entry, who have never been convicted of a felony or any crime of moral turpitude, and are not otherwise prohibited from entry as set forth herein. Ambition Strikes LLC ("Sponsor"), SweepstakesPros ("Promotion Administrator") and their respective parent companies, subsidiaries and affiliated companies, retailers, sales representatives, dealers, distributors, licensees and the advertising, fulfillment, judging and promotion agencies involved in the development and administration of this Promotion and each of their respective officers, directors, employees, representatives and agents (collectively, "Promotion Parties"), and members of their immediate families (defined as including spouse, biological, adoptive and step-parents, grandparents, siblings, children and grandchildren, and each of their respective spouses, regardless of where they reside) or households (whether related or not) of any of the above are not eligible to participate.   - b. **Subscription Entry:** During the promotion period visit the Website and follow the instructions to join the "Ambition Strikes Coffee Club" (the "Coffee Club"), complete all required information, and checkout using Coffee Club subscription to receive one hundred (100) entries in the Promotion (each a "Subscription Entry"). Monthly subscription cost is between \$14.45 and \$27.20 which is auto paid each month. You must remain a Coffee Club subscriber for at least one month to earn Subscription Entries. Coffee Club Subscriptions are automatically billed each month. Subscription Entries are earned in lieu of Purchase Entries.
  - c. **Mail-in Entry:** To enter the Promotion by mail without making a purchase, during the Promotion Period, handprint (in the following order) your full name, complete street address, daytime telephone number, email address, and birth date on a standard 4" x 6" postcard (with no outer envelope) and mail it to: The Ambition Strikes Weekend Trip Sweepstakes, PO Box 2442, Saratoga, CA 95070 (a "Mail-in Entry"). If the Promotion Period end date falls on a Sunday or federal holiday, the Mail-in Entry may be postmarked on the following day. Harassment, discrimination, bullying, or any form of abusive behavior will not be tolerated.
- iii. **Appropriate Demeanor:** Entrant shall maintain a demeanor consistent with the positive and professional image of the Sponsor and shall ensure their invited guest(s) also maintains such a demeanor. This includes refraining from:
  - 1. **Vulgarity and Profanity:** The use of excessively vulgar, obscene, or profane language, gestures, or imagery.
  - 2. **Inappropriate Dress or Appearance:** Dressing or appearing in a manner that is overtly suggestive, indecent, or inconsistent with the general tone and expectations of the Events, as determined by the Sponsor in its sole discretion, and taking into account generally accepted standards of decency and taste in the relevant jurisdiction. While creative expression is encouraged, it must remain within reasonable bounds of taste and decency as solely determined by the Sponsor.
  - 3. **Excessive Intoxication or Substance Abuse:** Engaging in excessive consumption of alcohol or using illegal drugs. Entrant acknowledges that public intoxication or any impairment that negatively impacts their ability to represent the Sponsor appropriately is prohibited.
  - 4. **Disparagement:** Making derogatory, defamatory, or disparaging statements, whether verbally, in writing, or through social media, about the Sponsor, its affiliates, employees, other entrants, event organizers, or sponsors.

- c. **Right to Terminate/Remove:** In the event that Entrant violates any provision of this Morality Clause, the Sponsor reserves the absolute right, in its sole discretion, to:
  - i. Immediately remove Entrant (and their guests) from the Events and any applicable travel arrangements, at Entrant's sole expense for return travel.
  - ii. Disqualify Entrant from any further participation in any of Sponsor's Events or any future association with the Sponsor.
  - iii. Demand the immediate cessation of any objectionable conduct or content.
  - iv. Pursue any other remedies available at law or in equity for breach of contract, including, but not limited to, damages for harm to reputation.

In addition, the Promotion Administrator, in its sole discretion, may disqualify any winner and cause forfeiture of any and all prizes won by the winning entrant in this Promotion and any
