- b. **Bonus Purchase Entry:** During the Promotion Period, one or more opportunities to receive “Bonus Ticket Purchase Entries” may be announced on the Website or in Sponsor’s communications. Bonus Purchase Entries will be awarded for all purchases made on the Sweepstakes Page and the Website or for only specific product purchases made on the Website during the specified entry dates/times (each a “Bonus Entry Period”).
