1. **Eligibility:** The Senior Movie Sweepstakes (the "Promotion") is open only to legal residents of the 50 United States (excluding NY and FL) and the District of Columbia (the "Territory") who have reached the legal age of majority in their state, are located in the Territory at the time of entry, who have never been convicted of a felony or any crime of moral turpitude, and are not otherwise prohibited from entry as set forth herein. Angel Studios Inc. Each drawing will be conducted by the Promotion Administrator from among all eligible entries received through all entry methods combined by the date immediately preceding each drawing. Entries included in each individual Entry Period 1-6 prize drawing will roll over into subsequent Entry Period 1-6 prize drawings.
 - b. **Cash Prize and Grand Prize Drawing:** On or about October 31, 2025, the Promotion Administrator will conduct a random drawing from among all eligible entries received during the entire Promotion Period to award the Cash prize and the Grand prizes.
7. **Prizes & Approximate Retail Value ("ARV"):**
- a. **Six (6) Entry Period 1-6 Prizes:** \$10,000 awarded in the form of a check. Total ARV of all Entry Period Prizes is \$60,000.
 - b. **One (1) Cash Prize:** \$50,000 awarded in the form of a check. Total ARV is \$50,000.
 - c. **Five (5) Grand Prizes:** Five (5) individuals will be selected as "Designation Prize Winners". Each Designation Prize Winner will receive the exclusive, non-transferable right to designate one (1) eligible student to receive a four-year "Scholarship" to Sul Ross State University ("SRSU") for enrollment at any of its campuses. The ARV of each Scholarship, if fully utilized by an eligible Scholarship Recipient is up to \$113,104. The total ARV of all Scholarships awarded as a result of these Designation Prizes is up to \$565,520. The final ARV will depend on the specific campus/site selected by the Scholarship recipient and the utilization of all

available scholarship benefits. Each Scholarship, which will be awarded directly by the Sponsor or SRSU to the designated student (the "Scholarship Recipient"), includes:

- i. **Academic Coverage:** Tuition, mandatory university fees, a standard board plan (if available at the selected campus/site), and an on-campus room (if available and utilized at the selected campus/site) (double occupancy, if applicable). This coverage is renewable for four (4) contiguous academic years, defined as the fall and spring semesters of each academic year.
- ii. **Exclusions:** All other costs and expenses associated with attending SRSU are the sole responsibility of the applicable Scholarship Recipient. These excluded costs and expenses include, but are not limited to, textbooks, supplies, laboratory fees, parking fees, transportation, personal expenses, incidentals, any costs associated with summer enrollment, and any costs related to housing or dining if such services are not available or not utilized at the Scholarship Recipient's chosen campus/site of enrollment.
- iii. **Direct Application of Funds:** All Scholarship funds will be applied directly to the Scholarship Recipient's student account each semester by SRSU. The Scholarship has no cash value, and no cash advances, refunds, or credits will be provided to the Scholarship Recipient.
- iv. **Non-Cash Value and Exclusivity:** The Scholarship is exclusive to Sul Ross State University (Alpine Campus or Rio Grande College sites) and cannot be redeemed for cash, credit, or any other value, nor can it be applied to tuition or expenses at any other educational institution.
- v. **Redemption Deadline:** The Scholarship Recipient must be accepted and successfully enrolled as a full-time, degree-seeking student at a Sul Ross State University campus/site (Alpine or Rio Grande College) no later than the start of the Fall 2026 academic semester. Failure of the Scholarship Recipient to enroll by this deadline will result in forfeiture of the Scholarship. Enrollment and continued use of the Scholarship are subject to compliance with all of Sul Ross State University's then-current admissions, academic, financial aid, and scholarship policies, as well as all applicable SRSU and Texas State University System rules and regulations. The availability of specific programs, housing, or dining plans may vary by campus/site, and the Scholarship Recipient is responsible for confirming the availability of such elements at their chosen campus/site.
- vi. **Designation Process and Eligibility:**
 - 1) **Winner Notification & Designation:** Each potential Designation Prize Winner will be notified in accordance with the Official Rules. To accept the Designation Prize, the potential Designation Prize Winner must, within 7 days of notification, formally designate an eligible student (who may be themselves) to be the Scholarship Recipient, by providing all requested information for the designated student, including but not limited to, the student's full legal name, date of birth, contact information, and social security number (for tax reporting purposes). Failure to complete a valid designation within the specified timeframe will result in forfeiture of the Designation Prize.
 - 2) **Scholarship Recipient Eligibility:** The designated Scholarship Recipient must meet all the general eligibility requirements set forth in the 'Eligibility' section of these Official Rules, in addition to the following specific requirements:

 - b) Be legal age of majority in their state of residence; and

standing and compliance with all applicable SRSU and Texas State University System rules and regulations throughout the duration of the scholarship.

The Scholarship will be automatically forfeited if the Scholarship Recipient fails to meet or maintain these requirements.

- 3) **No Transfer or Designation Right.** The right to designate a Scholarship Recipient is personal to the Designation Prize Winner and is non-transferable and non-assignable for any value or consideration.

- vii. **Tax Responsibility:** The Scholarship Recipient is solely responsible for any and all federal, state, and local taxes that may apply to the award and utilization of the scholarship. The Sponsor or SRSU will issue any required tax forms (e.g., Form 1099-MISC or Form 1098-T) to the Scholarship Recipient. These Official Rules attempt to award the Scholarship, and the taxes for each Scholarship, to the Scholarship Recipients, not to the Designation Prize Winners. However, this language is not a guarantee that the IRS will agree with this and the IRS may still tax the Designation Prize Winners. The Sponsor and Sul Ross State University do not provide tax advice and make no representations regarding the taxability of the scholarship. Total ARV of all prizes is up to \$675,520.
