1. **Eligibility:** The Young Washington Giveaway #2 (the “Promotion”) is open only to legal residents of the 50 United States and the District of Columbia (the “Territory”) who have reached the legal age of majority in their state of residence, are located in the Territory at the time of entry, and are not otherwise prohibited from entry as set forth herein. Angel Studios Inc. (“Sponsor”), SweepstakesPros (“Promotion Administrator”) and their respective parent companies, subsidiaries and affiliated companies, retailers, sales representatives, dealers, distributors, licensees and the advertising, fulfillment, judging and promotion agencies involved in the development and administration of this Promotion and each of their respective officers, directors, employees, representatives and agents (collectively, “Promotion Parties”), and members of their immediate families (defined as including spouse, biological, adoptive and step-parents, grandparents, siblings, children and grandchildren, and each of their respective spouses, regardless of where they reside) or households (whether related or not) of any of the above are not eligible to participate. 3. **Promotion Period:** The Promotion begins at 12:00 a.m. Pacific Time (“PT”) on February 15, 2026 and ends at 11:59 p.m. PT on July 10, 2026 (the “Promotion Period”).
4. **Launch Event:** On February 15, 2026, Sponsor will host a live graded Pokémon pack unboxing event (the “Launch Event”) from 06:00 p.m. PT to 08:00 p.m. PT on www.youtube.com/@loganpaulvlogs?si=6374VUMYUz9BpIP3 or www.ebay.com/ebaylive/sellers/wcwkf14sqvw. During the Launch Event, a pack from the Pokémon

Prize will be unboxed to reveal the specific cards to be awarded to the Pokémon Prize winner. Participation in/or viewing of the Launch Event is not a requirement for entry and will not increase an entrant's chances of winning.

5. **Entry Period:** There will be two (2) separate entry periods, during the Promotion Period as defined below (each an "Entry Period"). Each Entry Period will begin at 12:00 a.m. PT and end at 11:59 p.m. PT on the specified dates. Entry Periods will correspond to separate random prize drawings.

6. **How to Enter:**

- a. **Ticket Purchase Entry:** During the each Entry Period, visit www.angel.com (the "Website") or visit the Young Washington 2 page located at www.angel.com/giveaway/young-washington/sweepstake/young-washington-forging-freedom (the "Giveaway Page") and purchase one or more tickets for the Young Washington #2 movie (each a "Ticket") to earn entries in the Promotion based on the number of Tickets purchased in each individual order placed on the Website or the Giveaway Page (each a "Ticket Purchase Entry):

- b. **Bonus Entries:** During each Entry Period, one or more opportunities to receive "Bonus Ticket Purchase Entries" may be announced on the Website. Bonus Purchase Entries will be awarded for all purchases made during the specified entry dates. The Bonus Ticket Purchase Entries, the entry dates ("Bonus Entry Periods"), the bonus entry amounts awarded will be announced on the Website. Bonus Purchase Entries are earned in lieu of entries received for Ticket Purchase Entries.
- c. **Guild Member Entry:** Active Guild Members who book seats for the Young Washington 2 movie from the Giveaway Page during each Entry Period (each a "Booking") will earn fifty (50) entries in the Promotion for each seat booked ("Guild Member Entries"). Bookings must be made up to two (2) weeks before the Young Washington #2 movie's official release date of July 3, 2026. To sign up for a Guild membership, visit the Giveaway Page and follow the instructions to sign up for and purchase a Guild membership. If an Entry Period end date falls on a Sunday or federal holiday, the Mail-in Entry may be postmarked on the following day. All Mail-in Entries must be legibly handprinted (including addressing), mailed separately with no outer envelope, have sufficient postage, and require no recipient signature. 7. **Additional Entry Terms:** Entrants must complete all required information for each method of entry. Purchase transactions involving account adjustment transactions/returns, cancelled orders, fraudulent activity, or declined credit or debit transactions are not eligible for entries. To the maximum extent permitted by law, all entries and submissions become the exclusive property of the Sponsor and will not be acknowledged or returned except as provided herein.
8. **Prize Drawings:** On or about seven (7) days after the end of each applicable Entry Period Mail-in Entry Receive by Date stated in Section 5, the Promotion Administrator will conduct a random drawing to select one (1) winner from among all eligible entries received during the applicable Entry Period. **Entries included in an Entry Period Prize drawing will not roll over into the subsequent Entry Period prize drawing.**
9. **Prizes & Approximate Retail Value (“ARV”):**
 - a. **Pokémon Prize:** One (1) graded Pokémon pack opened during the live Launch Event (ARV: up to \$38,000) and one (1) unopened Pokémon Pack (ARV up to: \$33,000). ARVs are estimates as of the start of the Promotion and may vary. Actual value of each Pokémon pack depends on the specific cards contained in the pack and prevailing market prices at the time the prize is awarded. Total ARV of the Pokémon Prize is \$78,000. By entering, entrants acknowledge that one of the Pokémon packs in the Pokémon Prize will be opened prior to being awarded.
 - b. **Celebrating America Prize:**
 - i. A Celebrating America Trip Package for Two (2): A 250 Years Strong Tour for the winner and a guest from October 5, 2026 through October 15, 2026. The trip package is a 10-day / 9-night trip which consists of the following (total ARV of the trip is up to \$15,200) (the “Trip”):

 - 5) A guided multi-city U.S. historical tour for two (2) consisting of visiting key revolutionary and national landmarks in Boston, Connecticut, New York City, Philadelphia, Washington, DC, and Alexandria, including guided sightseeing, select museum visits, and featured excursions highlighting America’s 250th anniversary.
 - 6) Post-trip one-day add-on featuring a Mount Vernon VIP Tour with a private guide, including the mansion (off-view spaces as available), grounds,

museum, wreath-laying at George Washington's Tomb, one (1) night accommodations, and transfers. If the Mount Vernon add-on is unavailable for any reason, a \$1,500 cash alternative will be provided.

- ii. One (1) Antique Musket from the French/Indian War with an ARV of up to \$27,000.
- iii. \$10,000 cash awarded in the form of check.

Total ARV of the Celebrating America Prize is up to \$52,200.

Actual value of Trip portion of the prize depends on fare fluctuations and point of departure; any difference between stated and actual value will not be awarded. **The Celebrating America Prize winner and guest must take the Trip from October 5, 2026 through October 15, 2026 or the Trip portion of the prize will be forfeited in its entirety and will not be awarded, with no cash or other substitute compensation.** Unless Sponsor approves a shorter booking window in writing, Trip must be booked at least thirty (30) days prior to departure. Dates, location, and all travel arrangements/accommodations are at Sponsor's sole discretion and are subject to availability, blackout dates, and change. If, in Sponsor's judgment, air travel is not required due to winner's proximity to the destination, ground transportation may be substituted for air travel without

additional compensation. All travel expenses not specifically listed, including but not limited to, transportation between winner's home and the nearest major airport (as determined by Sponsor), ground transportation, meals, incidentals, gratuities, airline fees, surcharges, airport fees, service or facility charges, lodging personal charges, security fees, taxes, and other expenses, are the sole responsibility of winner and any travel companion(s) and must be paid by winner at booking where applicable. Winner and travel companion(s) must travel on the same itinerary and comply with all security and public-health requirements. Travel companion(s) may be required to sign and return a travel/liability release and, where lawful, a publicity release within the stated time as a condition of travel. Once travel documents are issued, neither travel arrangements nor travel companion(s) may be changed without Sponsor approval. Sponsor will not replace lost, mutilated, or stolen tickets, vouchers, or certificates. Promotion Parties are not liable for delays, cancellations, or unforeseen events related to transportation. 13. **Winner's Conduct:** Winner and any guest(s)/travel companion(s), if applicable, must conduct themselves at all times in a professional and respectful manner, consistent with the positive image of Sponsor, while participating in any Promotion-related trip, event, or activity (each, an "Activity"). This includes adherence to all applicable laws and venue rules, refraining from excessive intoxication or illegal substance use, and avoiding any conduct, on-site or online, that could disparage or reflect negatively on Sponsor. Winner is responsible for the conduct of guest(s)/travel companion(s), and any breach by a guest/companion will be deemed a breach by winner. Failure to comply may result in immediate removal from any Activity without notice or compensation, forfeiture of any prize, and disqualification from current or future promotions, in each case as determined by Promotion Administrator, in its sole discretion, with all associated costs (including return travel, if applicable) and any damages caused by winner or guest(s)/companion(s) at winner's expense. The Promotion Parties further reserve all other rights and remedies at law and in equity.
14. **Odds of Winning:** Odds of winning a prize depend on the number of eligible entries received.
15. **Entrant Verification:** In the event of a dispute regarding the identity of the person submitting an entry, the entry will be declared made by the natural person in whose name the entry was made. The

Promotion Administrator reserves the right to require proof of identity and/or eligibility (in a form acceptable to the Promotion Administrator – including, without limitation, government issued photo identification) for any reason the Promotion Administrator deems necessary, in its sole discretion, for the purposes of administering this Promotion in accordance with these Official Rules. Failure to provide such proof to the complete satisfaction of the Promotion Administrator within the timeline specified by the Promotion Administrator may result in disqualification by the Promotion Administrator, in its sole discretion.

16. **Disqualification:** Entries which are incomplete, incorrect, incomprehensible, not received, or do not otherwise comply with these Official Rules (as determined by the Promotion Administrator in its sole and absolute discretion) will be void and will not be entered into or be eligible to win a prize in the Promotion's prize drawing(s). 17. **Notification & Validation of Winners:** Potential winners, at Promotion Administrator's discretion, will each be contacted by telephone, email, regular mail or overnight mail, and may be required to complete, sign and return an affidavit or declaration of eligibility, a liability release, tax forms, and where lawful, a publicity release within a stated amount of time as a condition to receive any prize. Failure to comply will result in forfeiture of all rights to the prize(s). 18. **Limitations:** To the fullest extent permitted by applicable law, Promotion Parties are not responsible for: (i) electronic or digital transmissions, entries or mail that are lost, late, stolen, incomplete, illegible, damaged, garbled, destroyed, misdirected, not delivered, or not received by Sponsor or Promotion Administrator for any reason; (ii) mail that is received postage-due; (iii) any problems or technical malfunctions, errors, omissions, interruptions, deletions, defects, delays in operation or transmission, communication failures (including but not limited to failures or malfunctions of phone lines, mail delivery service, telephone systems or other communications systems), destruction of or unauthorized access to, or alteration of, entries, or for printing, distribution or production errors; (iv) failed or unavailable hardware, network, software or telephone transmissions; (v) damage to entrants' or any person's computer; (vi) causes beyond Promotion Parties' reasonable control that jeopardize the administration, security, fairness, integrity or proper conduct of this Promotion; (vii) incorrect or inaccurate entry information whether caused by entrants or by any of the equipment or programming associated with or utilized in the Promotion; (viii) any typographical or other error in the printing or advertising related to the Promotion, in the administration or execution of the Promotion, or in the announcement/notification of prize winners; (ix) any human, or other error, which may occur in the promotion, administration, or execution of this Promotion; or (x) cheating or fraud by any participant.
