

Hodgetwins # 8 Sweepstakes Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. PURCHASE OR PAYMENT DOES NOT IMPROVE YOUR CHANCE OF WINNING.

1. **Eligibility:** The Hodgetwins #8 Sweepstakes (the "Promotion") is open only to legal residents of the 48 contiguous United States and the District of Columbia (excluding New York and Florida) (the "Territory") who have reached the legal age of majority in their state of residence and are located in the Territory at the time of entry. Monthly subscription cost is between \$9 and \$150 which is auto paid each month. Entrants must complete all required information. You will receive ten (10) entries in the Promotion for providing your mobile phone number and ten (10) additional entries for providing your email address in the Sign-Up Form ("Sign Up Entries"). LIMIT TWENTY (20) SIGN UP ENTRIES PER PERSON/EMAIL ADDRESS/MOBILE PHONE NUMBER. You may unsubscribe from these email announcements without affecting your chances of winning this Promotion. - d. **Wellness Product Purchase Entry:** During the Promotion Period, visit any one of the Websites to purchase one or more "Wellness Products" from any of the Websites ("Wellness Entry"). Entrants must complete all required information. **RECEIVE TWO (2) ENTRIES FOR EVERY \$1 USD SPENT ON WELLNESS PRODUCTS** (not including tax and shipping). Purchase transactions involving account adjustment transactions/returns, declined credit or debit transactions are not eligible for Purchase Entries.
