1. **Eligibility:** The CBoysTV Car Giveaway (the “Promotion”) is open only to legal residents of the 50 United States and the District of Columbia and Canada (excluding Quebec) (the “Territory”) who are 13 years of age or older, are located in the Territory at the time of entry, and are not otherwise prohibited from entry as set forth herein. Cormorant Boys LLC (“Sponsor”), SweepstakesPros (“Promotion Administrator”) and their respective parent companies, subsidiaries and affiliated companies, retailers, sales representatives, dealers, distributors, licensees and the advertising, fulfillment, judging and promotion agencies involved in the development and administration of this Promotion and each of their respective officers, directors, employees, representatives and agents (collectively, “Promotion Parties”), and members of their immediate families (defined as including spouse, biological, adoptive and step-parents, grandparents, siblings, children and grandchildren, and each of their respective spouses, regardless of where they reside) or households (whether related or not) of any of the above are not eligible to participate. 2. **Decisions:** By participating in this Promotion, entrants agree to abide by and be bound by the Official Rules and the decisions of the independent Promotion Administrator, which shall be final in all matters relating to the Promotion. Where lawful, entrants waive any right to challenge such decisions.
3. **Minors:** If an entrant is not of the legal age of majority in the jurisdiction in which he/she resides (a “Minor”), the Minor must have the consent of a parent or legal guardian to participate in the Promotion. The Sponsor or Promotion Administrator may require proof of consent at any time and in any manner they deem appropriate. The Minor’s parent or legal guardian must agree to all terms and conditions set forth in these Official Rules and confirm this agreement in writing, or the Minor will be

disqualified. If a Minor is selected as a potential winner, the Minor's parent or legal guardian must sign and return all required documentation, including, where lawful, a Publicity Release, within the time frame specified. Failure to comply will result in forfeiture of all rights to the prize(s). If a prize is won by a Minor, it will be awarded in the name of the winner's parent or legal guardian.

4. **Promotion Period:** The Promotion begins at 7:00 p.m. Central Time ("CT") on June 4, 2026 and ends at 11:59 p.m. CT on July 12, 2026 (the "Promotion Period").

 - a. **Purchase Entry:** During the Promotion Period, visit the www.cboystv.com (the "Website") and purchase one or more products from the Website to receive one (1) entry in the Promotion for each \$5 USD spent (excluding tax and shipping) (each a "Purchase Entry").
 - b. **Mail-in Entry:** To enter the Promotion by mail without making a purchase, during the Promotion Period, handprint (in the following order) your full name, complete street address, daytime telephone number, email address, and birth date on a standard 4" x 6" postcard (with no outer envelope) and mail it to: CBoysTV Car Giveaway, PO Box 2442, Saratoga, CA 95070 (a "Mail-in Entry"). You will receive ten (10) entries into the Promotion for each Mail-in Entry received. Mail-in Entry requests must be postmarked during the Promotion Period and received by July 20, 2026. If the Promotion Period end date falls on a Sunday or federal holiday, the Mail-in Entry may be postmarked on the following day. All Mail-in Entries must be legibly handprinted (including addressing), mailed separately with no outer envelope, have sufficient postage, and require no recipient signature. **LIMIT ONE HUNDRED (100) MAIL-IN ENTRIES, WHICH IS TEN (10) MAIL-IN POSTCARDS, PER PERSON/EMAIL ADDRESS, SUBJECT TO THE MAXIMUM NUMBER OF TOTAL ENTRIES LISTED BELOW. 6. **Additional Entry Terms:** Entrants must complete all required information for each method of entry. The process for random selection and the location of the Grand Prize Drawing shall be determined solely by the Sponsor.
9. **Prizes & Approximate Retail Value ("ARV"):** Three (3) Car Prizes will be awarded:
 - a. The first Potential Winner, drawn from the ten (10) finalists, may choose one (1) of the following vehicle prizes (each a "Vehicle"):
 - i. A used 2020 Dodge Hellcat Redeye (ARV: \$65,000 USD)
 - ii. A used 2022 Chevy Camaro ZL1 (ARV: \$65,000 USD)
 - iii. A used 2017 Ford Mustang GT350 (ARV: \$50,000 USD)
 - b. The second Potential Winner, drawn from the ten (10) finalists, will choose from the two (2) remaining Vehicles not chosen by the first Potential Winner.
 - c. The third Potential Winner, drawn from the ten (10) finalists, will receive the remaining Vehicle.

Each Car Prize includes:

- i. \$10,000 USD cash awarded in the form of a check,
- ii. A trip for the winner (and/or the winner's parent or legal guardian if the winner is a minor) to Audubon, Minnesota (the "Trip Destination") to meet the CBoys TV Crew. 13. **Entrant's Conduct:** Entrant and any guest(s)/travel companion(s), if applicable, must conduct themselves at all times in a professional and respectful manner, consistent with the positive image of Sponsor, while participating in any Promotion-related trip, event, or activity (each, an "Activity"). This includes adherence to all applicable laws and venue rules, refraining from excessive intoxication or illegal substance use, and avoiding any conduct, on-site or online, that could disparage or reflect negatively on Sponsor. Entrant is responsible for the conduct of guest(s)/travel companion(s), and any breach by a guest/companion will be deemed a breach by entrant. Failure to comply may result in immediate removal from any Activity without notice or compensation, forfeiture of any prize, and disqualification from current or future promotions, in each case as determined by Promotion

For entries tied to a qualifying purchase where the order is placed in a business or entity name, the entry will be attributed, in Promotion Administrator's sole discretion, to the natural person identified (in order) by: (a) shipping recipient name, (b) billing name, or (c) payment-cardholder name (if available). If no natural person is identified, the order is void and not an eligible entry. Businesses and entities have no claim to any prize. The Promotion Administrator reserves the right to require proof of identity and/or eligibility (in a form acceptable to the Promotion Administrator – including, without limitation, government issued photo identification) for any reason the Promotion Administrator deems necessary, in its sole discretion, for the purposes of administering this Promotion in accordance with these Official Rules. Failure to provide such proof to the complete satisfaction of the Promotion Administrator within the timeline specified by the Promotion Administrator may result in disqualification by the Promotion Administrator, in its sole discretion.
16. **Disqualification:** Entries which are incomplete, incorrect, incomprehensible, not received, or do not otherwise comply with these Official Rules (as determined by the Promotion Administrator in its sole and absolute discretion) will be void and will not be entered into or be eligible to win a prize in the Promotion's prize drawing(s). Entries made by facsimile, overnight courier, bulk submission, automated means, any entry service, or in any other manner not specifically allowed under these Official Rules will not be entered into the Promotion and may result in disqualification of the entries and the responsible entrant(s), as determined by the Promotion Administrator in its sole and absolute discretion. Promotion Administrator reserves the right, in its sole and absolute discretion, to disqualify any individual who tampers with or attempts to tamper with the entry process or who acts in a disruptive or unfair manner or who otherwise fails to comply with these Official Rules.
17. **Notification & Validation of Winners:** Potential winners, at Promotion Administrator's discretion, will each be contacted by telephone, email, regular mail or overnight mail, and may be required to complete, sign and return an affidavit or declaration of eligibility, a liability release, tax forms, and where lawful, a publicity release within a stated amount of time as a condition to receive any prize. Failure to comply will result in forfeiture of all rights to the prize(s). The return of any notification as undeliverable or failure to respond to notices or return any required documents or information in a timely manner or a determination that a potential winner is ineligible or not in compliance with these Official Rules, as determined by the Promotion Administrator, in its sole and absolute discretion, may result in disqualification and forfeiture of any prize without further notice and may result in the selection of an alternate winner in a random drawing from among the remaining eligible entries. In the event of any conflict between these Official Rules and this Privacy Policy, these Official Rules shall control.
