1. **Eligibility:** The CboysTV Lamborghini Giveaway (the “Promotion”) is open only to legal residents of the 50 United States and the District of Columbia and Canada (excluding Quebec) (the “Territory”) who are 13 years of age or older, are located in the Territory at the time of entry, and are not otherwise prohibited from entry as set forth herein. However, if the purchase amount exceeds the gift card value, entries can be earned based on the remaining balance after the gift card has been applied.
