1. **Eligibility:** The CboysTV Ford Raptor Giveaway (the “Promotion”) is open only to legal residents of the 50 United States and the District of Columbia and Canada (excluding Quebec) (the “Territory”) who have reached the legal age of majority in their state/province/territory of residence, are located in the Territory at the time of entry and are not otherwise prohibited from entry as set forth herein. Purchases made with a gift card do not qualify for entries. However, if the purchase amount exceeds the gift card value, entries can be earned based on the remaining balance after the gift card has been applied. For example, a \$100 purchase using a \$50 gift card would earn 10 entries based on the \$50 remaining balance.
