Nomad RZR Giveaway Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. PURCHASE OR PAYMENT DOES NOT IMPROVE YOUR CHANCE OF WINNING.

- 1. Eligibility: The Nomad RZR Giveaway (the "Promotion") is open only to legal residents of the 50 United States and the District of Columbia and Canada (excluding Quebec) (the "Territory") who are 18 years of age or older and located in the Territory at the time of entry.
