

**Nomad RZR Giveaway  
Official Rules**

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. PURCHASE OR PAYMENT DOES NOT IMPROVE YOUR CHANCE OF WINNING.**

1. **Eligibility:** The Nomad RZR Giveaway (the "Promotion") is open only to legal residents of the 50 United States and the District of Columbia and Canada (excluding Quebec) (the "Territory") who are 18 years of age or older and located in the Territory at the time of entry. Diesel Power Gear LLC ("Sponsor"), SweepstakesPros ("Promotion Administrator") and their respective parents, subsidiaries and affiliated companies, retailers, sales representatives, dealers, distributors, licensees and the advertising, fulfillment, judging and promotion agencies involved in the development and administration of this Promotion and each of their respective officers, directors, employees, representatives and agents (collectively, "Promotion Parties"), and their immediate family members and persons living in the same households of each (whether related or not) are not eligible to participate. The Promotion is subject to all applicable federal, state, provincial/territorial, local and municipal laws and is void outside the Territory and where prohibited by law. Entrants must complete all required information for each purchase. Receive one (1) entry for every \$5 spent (not including shipping) subject to the limitation on entries noted below. Purchase transactions involving account adjustment transactions/returns, declined credit or debit transactions are not eligible for Purchase Entries.
