

**Power Club Indian Scout Giveaway  
Official Rules**

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. PURCHASE OR PAYMENT DOES NOT IMPROVE YOUR CHANCE OF WINNING.**

1. **Eligibility:** The Power Club Indian Scout Giveaway (the "Promotion") is open only to legal residents of the 50 United States and the District of Columbia and Canada (excluding Quebec) (the "Territory") who are 18 years of age or older and located in the Territory at the time of entry. Diesel Power Gear LLC ("Sponsor"), SweepstakesPros ("Promotion Administrator") and their respective parents, subsidiaries and affiliated companies, retailers, sales representatives, dealers, distributors, licensees and the advertising, fulfillment, judging and promotion agencies involved in the development and administration of this Promotion and each of their respective officers, directors, employees, representatives and agents (collectively, "Promotion Parties"), and their immediate family members and persons living in the same households of each (whether related or not) are not eligible to participate.   - b. **Mail-in Entry:** To obtain an entry without purchasing a subscription Box, legibly handprint your name, street address, city, state or province, zip or postal code, country, telephone number, complete e-mail address on a standard 4" x 6" postcard (with no outer envelope) and mail to: Power Club Indian Scout Giveaway, P.O. Mail-in Entry requests must be postmarked on or before July 31, 2021 and received by August 9, 2021. All Mail-in Entries must be legibly handwritten (including addressing), mailed separately with no outer envelope and have sufficient postage.
