# DBC December 2023 Giveaway Official Rules

# NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. PURCHASE OR PAYMENT DOES NOT IMPROVE YOUR CHANCE OF WINNING.

- 1. Eligibility: The DBC December 2023 Giveaway (the "Promotion") is open only to fans of the Dirt Bike Channel who are legal residents of the 50 United States and the District of Columbia (the "Territory") who have reached the legal age of majority in their state of residence and are located in the Territory at the time of entry. Dirt Bike Channel LLC ("Sponsor"), SweepstakesPros ("Promotion Administrator") and their respective parent companies, subsidiaries and affiliated companies, retailers, sales representatives, dealers, distributors, licensees and the advertising, fulfillment, judging and promotion agencies involved in the development and administration of this Promotion and each of their respective officers, directors, employees, representatives and agents (collectively, "Promotion Parties"), and members of their immediate families (defined as including spouse, biological, adoptive and step-parents, grandparents, siblings, children and grandchildren, and each of their respective spouses, regardless of where they reside) or households (whether related or not) of any of the above are not eligible to participate. site, complete all required information, and you will receive twenty five (25) entries for each purchase transaction (an "Affiliate Purchase Entry"). Purchase transactions involving account adjustment transactions/returns, declined credit or debit transactions are not eligible for Affiliate Purchase Entry. You will receive one thousand (1,000) entries, per Bonus Mail-in Entry request. LIMIT ONE THOUSAND (1,000) BONUS MAIL-IN ENTRIES, WHICH IS ONE (1) BONUS MAIL-IN POSTCARD, PER PERSON/EMAIL ADDRESS, SUBJECT TO THE MAXIMUM NUMBER OF TOTAL ENTRIES LISTED BELOW. ENTRANTS THAT SEND IN MORE THAN THE MAXIMUM NUMBER OF POSTCARDS WILL BE DISQUALIFIED.

LIMIT ONE THOUSAND (1,000) TOTAL ENTRIES (INCLUDING ANY BONUS ENTRIES) MADE BY PURCHASE, AFFILIATE PURCHASE AND/OR MAIL-IN ENTRY PER PERSON DURING THE PROMOTION PERIOD. - 4. **Finalists Drawing:** On or about January 15, 2024, the Promotion Administrator will conduct a random drawing to select ten (10) finalists (the "Finalists") from among all eligible entries received during the entire Promotion Period.
- 5. **Winner Selection:** On a date and time to be announced by Sponsor, currently scheduled for January 22, 2024 between 6:00 PM and 8:00 PM CT, the Sponsor will randomly select two (2) potential winners (the "Potential Winners") from among the Finalists on a live show streamed by Sponsor and broadcasted on YouTube (the "Prize Event") as follows:

- a. The Sponsor will randomly select a Potential Winner among all eligible Finalists during the Prize Event.
- b. The Sponsor will call the phone number provided by the Potential Winner with his/her entry during the Prize Event.
- c. If the Potential Winner timely answers the phone, the Sponsor will ask him/her three (3) objective questions to determine if he/she is a fan of the Dirt Bike Channel.   - A used 2024 KTM 300 XC-W HardEnduro Dirt Bike (ARV \$14,000)
  - A used 2024 KTM 300 XC Dirt Bike (ARV \$ 12,000)
- b. One (1) First Prize: The second Potential Winner, subject to validation, will receive the remaining dirt bike not chosen by the Grand Prize winner.

The Promotion Administrator reserves the right to require proof of identity and/or eligibility (in a form acceptable to the Promotion Administrator including, without limitation, government issued photo identification) for any reason the Promotion Administrator deems necessary, in its sole discretion, for the purposes of administering this Promotion in accordance with these Official Rules. Failure to provide such proof to the complete satisfaction of the Promotion Administrator within the timeline specified by the Promotion Administrator may result in disqualification by the Promotion Administrator, in its sole discretion.
