 - b. One (1) potential "DBC Grand Prize Winner" will randomly selected from among the DBC Finalists to receive the DBC Grand Prize.

The DBC Garage Member Finalists and the DBC Finalists are collectively the "Finalists". The process for random selection and the location of the Grand Prize Drawing shall be determined solely by the Sponsor.

8. **Grand Prize Winner Selection Process:** On a date and time to be announced by Sponsor, currently scheduled for September 21, 2026, between 6:00 PM and 8:00 PM CT, the Sponsor will conduct the two (2) separate Grand Prize Drawings from among the eligible DBC Member Finalists and the DBC

Finalists, as applicable, on a live show streamed by Sponsor and broadcasted on YouTube (the “Prize Event”) as follows for each Grand Prize Drawing:

- a. The Sponsor will randomly select a Potential Winner among all applicable Finalists during the Prize Event.
- b. The Sponsor will call the phone number provided by the Potential Winner with his/her entry (or the phone number provided during any Finalist validation) during the Prize Event.
- c. If the Potential Winner timely answers the phone, the Sponsor will ask him/her three (3) objective questions to determine if he/she is a fan of the Dirt Bike Channel or, at Sponsor’s discretion. If the Potential Winner promptly and correctly answers two (2) of these questions, as determined by Sponsor, the Potential Winner will be selected as a Grand Prize winner for that drawing, subject to validation by the Promotion Administrator.
