

**Honor Bound USA S90 Car Sweepstakes
Official Rules**

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. PURCHASE OR PAYMENT DOES NOT IMPROVE YOUR CHANCE OF WINNING.

1. **Eligibility:** The Honor Bound USA S90 Car Sweepstakes (the "Promotion") is open only to legal residents of the 48 contiguous United States (excluding New York, Alaska and Hawaii), the District of Columbia and Canada (excluding Quebec) (the "Territory") who have reached the legal age of majority in their state/province/territory of residence, are located in the Territory at the time of entry and are not otherwise prohibited from entry as set forth herein.
