

**Win Jocko's Bronco Giveaway
Official Rules**

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. PURCHASE OR PAYMENT DOES NOT IMPROVE YOUR CHANCE OF WINNING.

- Eligibility:** The Win Jocko's Bronco Giveaway (the "Promotion") is open only to legal residents of the 48 contiguous United States and the District of Columbia (excluding Alaska and Hawaii) (the "Territory"), who have reached the legal age of majority in their state of residence, are located in the Territory at the time of entry and must have never been convicted of a felony or any crime of moral turpitude.
