

**Fox Factory Truck Sweepstakes
Official Rules**

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. PURCHASE OR PAYMENT DOES NOT IMPROVE YOUR CHANCE OF WINNING.

1. **Eligibility:** The Fox Factory Truck Sweepstakes (the "Promotion") is open only to legal residents of the 48 contiguous United States (excluding Hawaii, Alaska, New York and Florida) and the District of Columbia (the "Territory") who have reached the legal age of majority in their state of residence and are located in the Territory at the time of entry.
