

**Reeds 1993 Dodge Ram Giveaway #6
Official Rules**

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. PURCHASE OR PAYMENT DOES NOT IMPROVE YOUR CHANCE OF WINNING.

1. **Eligibility:** The Reeds 1993 Dodge Ram Giveaway #6 (the "Promotion") is open only to legal residents of the 48 contiguous United States (excluding Hawaii and Alaska) (the "Territory") who have reached the legal age of majority in their state of residence and are located in the Territory at the time of entry. Reeds Cattle Co. ("Sponsor"), SweepstakesPros ("Promotion Administrator") and their respective parent companies, subsidiaries and affiliated companies, retailers, sales representatives, dealers, distributors, licensees and the advertising, fulfillment, judging and promotion agencies involved in the development and administration of this Promotion and each of their respective officers, directors, employees, representatives and agents (collectively, "Promotion Parties"), and members of their immediate families (defined as including spouse, biological, adoptive and step-parents, grandparents, siblings, children and grandchildren, and each of their respective spouses, regardless of where they reside) or households (whether related or not) of any of the above are not eligible to participate. By participating in this Promotion, entrants agree to abide by and be bound by these Official Rules and decisions of the independent Promotion Administrator, which shall be final in all matters relating to the Promotion.
2. **Promotion Period:** The Promotion begins at 12:00 a.m. Mountain Time ("MT") on March 20, 2024 and ends at 11:59 p.m. MT on April 30, 2024 (the "Promotion Period").
3. **How to Enter:**
 - a. **Online Purchase Entry:** During the Promotion Period, visit www.reedscattleco.com (the "Website") and purchase one or more products from the Website to receive one (1) entry in the Promotion for each \$1 spent (not including tax or shipping) (each a "Purchase Entry").
 - b. **Bundle Purchase Entry:** During the Promotion Period, visit the Website and purchase one or more of the following bundled products to receive the associated number of entries in the Promotion for each purchase (each a "Bundle Purchase Entry"):
 - i. Gold Bundle (\$105): Receive 315 entries in the Promotion for each Gold Bundle purchased from the Website.
 - ii. Silver Bundle (\$70): Receive 140 entries in the Promotion for each Silver Bundle purchased from the Website.Bundle Purchase Entries are earned in lieu of entries received for Purchase Entries. Entrants must complete all the required information.
 - c. **Bonus Purchase Entry:** From April 20, 2024 through April 30, 2024 (the "Bonus Entry Period"), visit the "Website" and purchase one or more products from the Website to receive five (5) entries in the Promotion for each \$1 spent (not including tax or shipping) (each a "Bonus Purchase Entry"). Bonus Purchase Entries are earned in lieu of Purchase Entries and Bundle Purchase Entries.
 - d. **Mail-in Entry:** To enter the Promotion by mail without making a purchase, during the Promotion Period, handprint (in the following order) your full name, complete street address, daytime telephone number, email address, and birth date on a standard 4" x 6" postcard (with no outer envelope) and mail it to: Reeds 1993 Dodge Ram Giveaway #6, PO Box 3234, Saratoga, CA 95070 (a "Mail-in Entry"). You will receive one hundred fifty (150) entries into the Promotion for each Mail-in Entry received. Mail-in Entries must be received by May 7, 2024. All Mail-in Entries must be legibly handwritten (including addressing), mailed separately with no outer envelope, and have sufficient postage. LIMIT SIX HUNDRED (600) MAIL-IN ENTRIES, WHICH IS FOUR (4) MAIL-IN POSTCARDS, PER PERSON/EMAIL ADDRESS.

Entrants must complete all the required information. Purchase transactions involving account adjustment transactions/returns, declined credit or debit transactions are not eligible for Purchase Entries, Bundle Purchase Entries, or Bonus Purchase Entries. LIMIT SIX HUNDRED (600) ENTRIES PER PERSON/EMAIL ADDRESS/PHONE NUMBER REGARDLESS OF METHOD OF ENTRY. To the maximum extent permitted by law, all entries and submissions become the exclusive property of the Sponsor and will not be acknowledged or returned except as provided herein.

4. Random Drawings:

- a. **Finalist Drawing:** On or about May 14, 2024, the Promotion Administrator will conduct a random drawing for ten (10) finalists from among all eligible entries received during the entire Promotion Period.
- b. **Grand Prize Drawing:** On or about May 21, 2024, the Sponsor will randomly select one (1) Finalist to be the Grand Prize Winner. The process for random selection and the location of the Grand Prize Drawing shall be determined solely by the Sponsor. Further, the final date and location of the Grand Prize Drawing are subject to change at Sponsor's discretion.

5. **Prizes, Approximate Retail Value ("ARV") & Odds of Winning:** One (1) Grand Prize: A previously owned 1993 Dodge Ram V-6 Magnum (ARV \$15,000) and a one-way trip for the winner to pick up the prize at a pre-determined location in Show Low, Arizona (trip ARV up to \$1,000). Trip includes one-way air transportation from the major airport nearest winner's residence to Show Low, Arizona and hotel accommodations for one night. Total ARV of prize is up to \$16,000. Actual value of trip portion of the Grand Prize will depend on airfare fluctuations and point of departure. If the Promotion is terminated before the stated end date of the Promotion Period, the Promotion Administrator may select the winners in a random drawing from among all applicable eligible, non-suspect entries received as of the time/date of termination. Thereafter, Sponsor reserves the right to accept no further entries and award no further prizes.
