

**Reeds 1956 Truck Giveaway #7
Official Rules**

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. PURCHASE OR PAYMENT DOES NOT IMPROVE YOUR CHANCE OF WINNING.

1. **Eligibility:** The Reeds 1956 Truck Giveaway #7 (the "Promotion") is open only to legal residents of the 48 contiguous United States (excluding Hawaii and Alaska) (the "Territory") who have reached the legal age of majority in their state of residence and are located in the Territory at the time of entry. Reeds Cattle Co. ("Sponsor"), SweepstakesPros ("Promotion Administrator") and their respective parent companies, subsidiaries and affiliated companies, retailers, sales representatives, dealers, distributors, licensees and the advertising, fulfillment, judging and promotion agencies involved in the development and administration of this Promotion and each of their respective officers, directors, employees, representatives and agents (collectively, "Promotion Parties"), and members of their immediate families (defined as including spouse, biological, adoptive and step-parents, grandparents, siblings, children and grandchildren, and each of their respective spouses, regardless of where they reside) or households (whether related or not) of any of the above are not eligible to participate. 2. **Promotion Period:** The Promotion begins at 12:00 a.m. Mountain Time ("MT") on July 1, 2024 and ends at 11:59 p.m. MT on July 31, 2024 (the "Promotion Period").
3. **How to Enter:**
 - a. **Online Purchase Entry:** During the Promotion Period, visit www.reedscattleco.com and <https://reedscattlecobeefsales.com> (the "Websites") and purchase one or more products from the Websites to receive one (1) entry in the Promotion for each \$1 spent (not including tax or shipping) (each a "Purchase Entry").
 - b. **Bundle Purchase Entry:** During the Promotion Period, visit the www.reedscattleco.com and purchase one or more of the following bundled products to receive the associated number of entries in the Promotion for each purchase (each a "Bundle Purchase Entry"):
 - i. Gold Bundle (\$105): Receive 315 entries in the Promotion for each Gold Bundle purchased from www.reedscattleco.com.
 - ii. Silver Bundle (\$70): Receive 140 entries in the Promotion for each Silver Bundle purchased from www.reedscattleco.com.Bundle Purchase Entries are earned in lieu of entries received for Purchase Entries. Entrants must complete all the required information.
 - c. **Bonus Purchase Entry:** Periodically through the Promotion Period, you may earn "Bonus Purchase Entries" for purchases on the Websites as follows:
 - i. First Week Bonus: July 1 - 7, 2024: 30x entries: All Purchase Entries made during this time will receive thirty (30) entries for each \$1 spent (not including tax or shipping).
 - ii. Second Week Bonus: July 8 - 14, 2024: 20x entries: All Purchase Entries made during this time will receive twenty (20) entries for each \$1 spent (not including tax or shipping).
 - iii. Third Week Bonus: July 15 - 21, 2024: 25x entries: All Purchase Entries made during this time will receive twenty-five (25) entries for each \$1 spent (not including tax or shipping).

- iv. Fourth Week Bonus: July 22 - 31, 2024: 30x entries: All Purchase Entries made during this time will receive thirty (30) entries for each \$1 spent (not including tax or shipping).
- d. **Mail-in Entry:** To enter the Promotion by mail without making a purchase, during the Promotion Period, handprint (in the following order) your full name, complete street address, daytime telephone number, email address, and birth date on a standard 4" x 6" postcard (with no outer envelope) and mail it to: Reeds 1956 Truck Giveaway #7, PO Box 2781, Saratoga, CA 95070 (a "Mail-in Entry"). You will receive eight hundred seventy-five (875) entries into the Promotion for each Mail-in Entry received. Mail-in Entries must be received by August 7, 2024. All Mail-in Entries must be legibly handwritten (including addressing), mailed separately with no outer envelope, and have sufficient postage. **LIMIT THREE THOUSAND FIVE HUNDRED (3500) MAIL-IN ENTRIES, WHICH IS FOUR (4) MAIL-IN POSTCARDS, PER PERSON/EMAIL ADDRESS.**

LIMIT THREE THOUSAND FIVE HUNDRED (3,500) ONLINE PURCHASE ENTRIES, BUNDLE PURCHASE ENTRIES, BONUS PURCHASE ENTRIES, AND MAIL-IN ENTRIES COMBINED PER PERSON/EMAIL ADDRESS DURING THE PROMOTION PERIOD. Entrants must complete all the required information. Purchase transactions involving account adjustment transactions/returns, declined credit or debit transactions are not eligible for Purchase Entries, Bundle Purchase Entries, or Bonus Purchase Entries..  - b. **Grand Prize Drawing:** On or about August 21, 2024, the Sponsor will randomly select one (1) Finalist to be the Grand Prize Winner. The process for random selection and the location of the Grand Prize Drawing shall be determined solely by the Sponsor. Further, the final date and location of the Grand Prize Drawing are subject to change at Sponsor's discretion.
5. **Prizes, Approximate Retail Value ("ARV") & Odds of Winning:** One (1) Grand Prize: A previously owned 1956 Chevrolet (ARV \$21,000) and a one-way trip for the winner to pick up the prize at a pre-determined location in Show Low, Arizona (trip ARV up to \$1,000). Trip includes one-way air transportation from the major airport nearest winner's residence to Show Low, Arizona and hotel accommodations for one night. Total ARV of prize is up to \$22,000. Actual value of trip portion of the Grand Prize will depend on airfare fluctuations and point of departure.
