1. **Eligibility:** The Saint Potential Tesla Giveaway (the "Promotion") is open only to legal residents of the 48 contiguous United States (excluding New York, Florida, Alaska and Hawaii) and the District of Columbia (the "Territory") who have reached the legal age of majority in their state of residence, are located in the Territory at the time of entry and are not otherwise prohibited from entry as set forth herein.
