

**Town and Country TV Ford Bronco Giveaway
Official Rules**

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. PURCHASE OR PAYMENT DOES NOT IMPROVE YOUR CHANCE OF WINNING.

1. **Eligibility:** The Town and Country TV Ford Bronco Giveaway (the "Promotion") is open only to legal residents of the 48 contiguous United States (excluding Hawaii and Alaska) and the District of Columbia (the "Territory") who have reached the legal age of majority in their state of residence and are located in the Territory at the time of entry. Town and Country Ford, LLC ("Sponsor"), SweepstakesPros ("Promotion Administrator") and their respective parent companies, subsidiaries and affiliated companies, retailers, sales representatives, dealers, distributors, licensees and the advertising, fulfillment, judging and promotion agencies involved in the development and administration of this Promotion and each of their respective officers, directors, employees, representatives and agents (collectively, "Promotion Parties"), and members of their immediate families (defined as including spouse, biological, adoptive and step-parents, grandparents, siblings, children and grandchildren, and each of their respective spouses, regardless of where they reside) or households (whether related or not) of any of the above are not eligible to participate. 2. **Promotion Period:** The Promotion begins at 12:00 a.m. Pacific Time ("PT") on January 1, 2023 and ends at 11:59 p.m. PT on March 31, 2023 (the "Promotion Period"). There will be three (3) separate entry periods, during the Promotion Period (each a "Monthly Entry Period"). Each entry period will correspond to a separate random prize drawing (each a "Monthly Drawing"). See Rule 5, below for details. For purposes of this Promotion, each Monthly Entry Period is defined as a calendar month during the Promotion Period.
3. **How to Enter:**
 - a. **Purchase Entry:** During the Promotion Period, visit www.tccustoms.com (the "Website") and purchase one or more TCCustoms merchandise, excluding car accessories and parts (a "Purchase Entry"). Entrants must complete all required information. RECEIVE ONE (1) ENTRY FOR EACH \$1 SPENT (NOT INCLUDING TAX OR SHIPPING) DURING THE PROMOTION PERIOD. Purchase transactions involving gift card purchases, account adjustment transactions/returns, declined credit or debit transactions are not eligible for Purchase Entries.
 - b. **SMS Sign-up Entry:** During the Promotion Period, visit the Website, look for the pop-up form (the "Sign-up Form"), follow the on-screen directions, complete all required fields, provide your mobile phone number, and submit to receive one (1) entry in the Promotion (a "Sign-up Entry"). LIMIT ONE (1) SIGN-UP ENTRY PER PERSON/MOBILE NUMBER. If you provide your mobile phone number, you will receive up to ten (10) texts from an automated system. **Standard message and data rates may apply.** Text **STOP** to unsubscribe.  - c. **Mail-in Entry:** To enter the Promotion by mail, during the Promotion Period, handprint (in the following order) your full name, complete street address, daytime telephone number, email address and birth date, on a 4" x 6" postcard (with no outer envelope) and mail it to: Town and Country TV Ford Bronco Giveaway, PO Box 2781, Saratoga, CA 95070 (a "Mail-in Entry"). You will receive one-hundred seventy-five (175) entries into the Promotion for each postcard received. Postcards must be received by April 7, 2023. You may unsubscribe from these email announcements without affecting your chances of winning this Promotion. To the maximum extent permitted by law, all entries and submissions become the exclusive property of the Sponsor and will not be acknowledged or returned except as provided herein. 4. Bonus Entries:

All Bonus Mail-in Entries must be legibly handwritten (including addressing), mailed separately with no outer envelope and have sufficient postage. Bonus Purchase Entries and Bonus Mail-in Entries are earned in lieu of entries received for Purchase Entries and Mail-in Entries.

5. Prize Drawings:

- a. **Monthly Prize Drawings:** On or about ten (10) days after each Monthly Entry Period, the Promotion Administrator will conduct a random drawing from among all eligible entries received during (including all Mail-in Entries and Bonus Mail-in Entries received up to seven [7] days after) the applicable Monthly Entry Period to award one (1) Monthly Prize. Entries included in each Monthly Prize Drawing will roll-over into all subsequent prize drawings, including the Grand Prize Drawing.
- b. **Grand Prize Drawing:** On or about April 14, 2023, the Promotion Administrator will conduct a random drawing from among all eligible entries received during the entire Promotion Period to award the Grand Prize.

6. Prizes, Approximate Retail Value (“ARV”) & Odds of Winning:

- a. One (1) Grand Prize: A customized 2022 Ford Bronco (ARV \$59,000) and a one-way trip for the winner to pick up the prize at a pre-determined location in Alabama (trip ARV up to \$2,000). Total ARV for Grand Prize is \$61,000. Trip includes one-way air transportation from the major airport nearest winner’s residence to Bessemer, AL, and hotel accommodations for one night.
- b. Three (3) Monthly Prizes (one per Monthly Entry Period): TC Customs Gift Card, for use on Car Parts and Car Accessories on TCcustoms.com. The gift card is not eligible to purchase

merchandise or gain extra entries into the Sweepstakes (ARV \$550). Total ARV of all Monthly Prizes is \$1,650
