

**The Bronco Sport Sweepstakes
Official Rules**

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. PURCHASE OR PAYMENT DOES NOT IMPROVE YOUR CHANCE OF WINNING.

1. **Eligibility:** The Bronco Sport Sweepstakes (the "Promotion") is open only to legal residents of the 48 United States (excluding Florida, New York, Alaska and Hawaii) and the District of Columbia (the "Territory") who have reached the legal age of majority in their state of residence and are located in the Territory at the time of entry. Town & Country Ford, LLC ("Sponsor"), SweepstakesPros ("Promotion Administrator") and their respective parent companies, subsidiaries and affiliated companies, retailers, sales representatives, dealers, distributors, licensees and the advertising, fulfillment, judging and promotion agencies involved in the development and administration of this Promotion and each of their respective officers, directors, employees, representatives and agents (collectively, "Promotion Parties"), and members of their immediate families (defined as including spouse, biological, adoptive and step-parents, grandparents, siblings, children and grandchildren, and each of their respective spouses, regardless of where they reside) or households (whether related or not) of any of the above are not eligible to participate. 2. **Promotion Period:** The Promotion begins at 12:00 a.m. Central Time ("CT") on February 1, 2021 and ends at 11:59 p.m. CT on June 30, 2021 (the "Promotion Period").

Follow the on-screen directions, complete all required fields and submit to enter (a "Newsletter Entry") to receive ONE (1) entry in the Promotion. Entrants must complete all required information. LIMIT ONE (1) NEWSLETTER ENTRY PER PERSON/EMAIL ADDRESS.
 - b. **Purchase Entry:** During the Promotion Period, visit the Website and purchase one or more eligible items from this site during the Promotion Period (a "Purchase Entry"). Entrants must complete all required information. Receive one (1) entry for each apparel item purchased during the Promotion Period. Receive three (3) entries for each part item purchased during the Promotion Period. Purchase transactions involving account adjustment transactions/returns, declined credit or debit transactions are not eligible for Purchase Entries.  - d. **Mail-in Entry:** To obtain entries into the Promotion without making a purchase or dealership visit, legibly handprint (in the following order) your full name, complete street address, daytime telephone number, email address and birth date, on a 4" x 6" postcard (with no outer envelope) and mail it to: The Bronco Sport Sweepstakes, P.O. acceptable to the Promotion Administrator – including, without limitation, government issued photo identification) for any reason the Promotion Administrator deems necessary, in its sole discretion, for the purposes of administering this Promotion in accordance with these Official Rules. Failure to provide such proof to the complete satisfaction of the Promotion Administrator within the timeline specified by the Promotion Administrator may result in disqualification by the Promotion Administrator, in its sole discretion.

If the Promotion is terminated before the stated end date of the Promotion Period, the Promotion Administrator may select the winners in a random drawing from among all applicable eligible, non-suspect entries received as of the time/date of termination. Thereafter, Sponsor reserves the right to accept no further entries and award no further prizes.
11. **Releases:** To the maximum extent permitted by law, by participating in this Promotion, entrants (and agree to confirm in writing): (a) to the maximum extent permitted by law, that all causes of action arising out of or connected with this Promotion, or any prize awarded, shall be resolved individually,

14. **Choice of Law, Jurisdiction and Notice:** All issues and questions concerning the construction, validity, interpretation, and enforceability of these Official Rules, or the rights and obligations of the entrant and Sponsor in connection with the Promotion, shall be governed by, and construed in accordance with, the laws of the State of California, without giving effect to any choice of law or conflict of law rules (whether of the State of California or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of California. By entering, entrants irrevocably consent to the exclusive jurisdiction of the federal and state courts located within the county of Santa Clara, California for any action, suit or proceeding arising out of or relating to this Promotion.
