

**TCustoms Ford F250 Giveaway
Official Rules**

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. PURCHASE OR PAYMENT DOES NOT IMPROVE YOUR CHANCE OF WINNING.

1. **Eligibility:** The TCustoms Ford F250 Giveaway (the "Promotion") is open only to legal residents of the 48 contiguous United States (excluding Hawaii and Alaska) and the District of Columbia (the "Territory") who have reached the legal age of majority in their state/territory of residence and are located in the Territory at the time of entry.
