## The UTVI-3 Giveaway Official Rules

## NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. PURCHASE OR PAYMENT DOES NOT IMPROVE YOUR CHANCE OF WINNING.

- 1. Eligibility: The UTVI-3 Giveaway (the Promotion") is open only to legal residents of the 48 contiguous United States (excluding New York, Florida, Hawaii and Alaska.) and the District of Columbia (the "Territory") who have reached the legal age of majority in their state of residence and are located in the Territory at the time of entry. - b. **Grand Prize Drawing**: On or about October 21, 2024, the Sponsor will randomly select one (1) finalist to be the Grand Prize Winner. The process for random selection and the location
