1. **Eligibility:** The Waiākea Wellness Retreat Sweepstakes (the “Promotion”) is open only to legal residents of the 50 United States and the District of Columbia (the “Territory”) who have reached the legal age of majority in their state of residence, are located in the Territory at the time of entry, and are not otherwise prohibited from entry as set forth herein. Waiākea, Inc. 5. **Additional Entry Terms:** Entrants must complete all required information for each method of entry. LIMIT ONE ENTRY PER PERSON/EMAIL ADDRESS. To the maximum extent permitted by law, all entries and submissions become the exclusive property of the Sponsor and will not be acknowledged or returned except as provided herein.
