

**Jesse James Custom Welding Truck Giveaway  
Official Rules**

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. PURCHASE OR PAYMENT DOES NOT IMPROVE YOUR CHANCE OF WINNING.**

1. **Eligibility:** The Jesse James Custom Welding Truck Giveaway (the "Promotion") is open only to legal residents of the 50 United States and the District of Columbia (the "Territory") who have reached the legal age of majority in their state residence and are located in the Territory at the time of entry. Pipe ARC Solutions LLC ("Sponsor"), SweepstakesPros ("Promotion Administrator") and their respective parent companies, subsidiaries and affiliated companies, retailers, sales representatives, dealers, distributors, licensees and the advertising, fulfillment, judging and promotion agencies involved in the development and administration of this Promotion and each of their respective officers, directors, employees, representatives and agents (collectively, "Promotion Parties"), and members of their immediate families (defined as including spouse, biological, adoptive and step-parents, grandparents, siblings, children and grandchildren, and each of their respective spouses, regardless of where they reside) or households (whether related or not) of any of the above are not eligible to participate.     - v. Receive twenty-five (25) entries for each cap or beanie purchased.
    - vi. Receive twenty-five (25) entries for each t-shirt purchased.
    - vii. Receive thirty-five (35) entries for each welding gloves purchased.
    - viii. Receive fifty (50) entries for each hoodie purchased.
    - ix. Receive seventy-five (75) entries for each pair of sunglasses purchased.
    - x. Receive two hundred (200) entries for each welding hood purchased.
    - xi. Receive three hundred (300) entries for each amplified welding tig rig purchased.Entrants must complete all required information. Purchase transactions involving account adjustment transactions/returns, declined credit or debit transactions are not eligible for Purchase Entries.
