## YellaWood Five-Star Hero Contest Official Rules

## NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. PURCHASE OR PAYMENT DOES NOT IMPROVE YOUR CHANCE OF WINNING.

- 1. Eligibility: The YellaWood Five-Star Hero Contest (the "Promotion") is open only to Nominators and Heroes (as defined below) who are legal residents of the following U.S. States: Alabama, Georgia. Florida, Mississippi, Louisiana, Texas, Tennessee, Kentucky, South Carolina, North Carolina, Virginia, Maryland, West Virginia, Delaware, New York, New Jersey, Pennsylvania, Ohio, Indiana, Illinois, Iowa, Missouri, Arkansas, Oklahoma, Kansas, Nebraska and the District of Columbia (the "Territory"), who have reached the legal age of majority in their state of residence, who are located in the Territory at the time of entry, and who have never been convicted of a felony or a crime of moral turpitude. Great Southern Wood Preserving Incorporated ("Sponsor"), SweepstakesPros ("Promotion Administrator") and their respective parent companies, subsidiaries and affiliated companies, retailers, sales representatives, dealers, distributors, licensees and the advertising, fulfillment, judging and promotion agencies involved in the development and administration of this Promotion and each of their respective officers, directors, employees, representatives and agents (collectively, "Promotion Parties"), and members of their immediate families (defined as including spouse, biological, adoptive and step-parents, grandparents, siblings, children and grandchildren, and each of their respective spouses, regardless of where they reside) or households (whether related or not) of any of the above are not eligible to participate. Sponsor or Promotion Administrator may require proof of consent at any time and in any manner they deem appropriate. Other eligibility requirements and conditions of participation are set forth below in these official rules for the Promotion ("Official Rules").
- 2. **Promotion Period:** The Promotion begins at 12:00 a.m. Eastern Time ("ET") on April 15, 2024, and ends at 11:59 p.m. ET on August 16, 2024 (the "Promotion Period").
- 3. **Nominators & Nominees**: The participant who submits the Entry (as defined below) in this Promotion is referred to herein as the "Nominator" and the person who the Entry is about is referred to herein as the "Nominee or Hero". A Nominator may submit a person who he/she believes qualifies as a Hero. Nominators may only enter Heroes with whom they have an existing personal relationship and can contact if the Hero is selected as a potential winner. A Nominator cannot submit him/herself as a Hero.
- 4. How to Enter: During the Promotion Period visit www.YellaWoodHero.com and locate the official entry form. Follow the instructions. Upload a video or submit an essay about an everyday, ordinary American hero who makes a difference, represents patriotism, duty, honor, country, family-values, and/or puts others before themselves (the "Theme.") Complete all required fields and submit the entry form to receive one (1) entry in the Promotion (an "Entry"). Entries must follow the submission requirements set forth herein and comply in all respects with these Official Rules. Nominators may enter as often as they wish, but each Entry must be different, and they must submit a different Hero for each Entry. Heroes may only be entered one time. If a Hero is entered more than one time, only the first eligible entry received will be valid, all other entries for the same Hero will be disqualified. All Entries are subject to a review by Promotion Administrator and Sponsor prior to Sponsor posting online. By submitting your Entry, you represent that your Entry conforms to the submission guidelines set forth herein and with all of these Official Rules, and agree that the Promotion Administrator, in its sole discretion, may remove your Entry and disqualify you from the Promotion if it believes, in its sole discretion, that your Entry fails to conform to the submission requirements or to these Official Rules in any way.

## 5. Conditions of Submission:

## a. Submission Guidelines:

- 1. The Entry submitted must be created by the entrant alone, be true, and be verifiable.
- 2. The Entry must be entrant's original creation; modifying, enhancing or altering a third party's preexisting work does not qualify as an entrant's original creation.
- 3. The Entry must submit a Hero who is a natural, living person the Nominator has an existing personal relationship and with whom a message from the Nominators would not be considered spam.
- 4. Essays must be two-hundred and fifty (250) words or fewer.
- 5. Videos must be uploaded in one of the following formats: .mov, .avi, .mkv, .mp4, .m4v, .mpg, .mpeg, .wmv and .3gp and must be between one (1) and two (2) minutes long and no more than 100 MB in size.
- 6. The Nominator and Hero nominated for each Entry must both reside within the Territory.
- 7. All Entries must be in English.
- b. Additional Conditions of Submission: Any Entry which the Promotion Administrator or Sponsor, in their sole opinion, deem to be inappropriate for publication or inclusion in this Promotion will not be considered or displayed and the corresponding entrant will be disgualified. Entry cannot, in the opinion of the Promotion Administrator or Sponsor: (i) be sexually explicit or suggestive, unnecessarily or overly violent or derogatory of any ethnic, racial, gender, religious, professional or age group, profane or pornographic, contain nudity or any materially dangerous activity; (ii) promote alcohol, illegal drugs, tobacco, firearms/weapons (or the use of any of the foregoing), any activities that may appear unsafe or dangerous, or any particular political agenda or message; (iii) be obscene or offensive, endorse any form of hate or hate group; (iv) defame, misrepresent or contain disparaging remarks about Sponsor or its products, or other people, products or companies; (v) contain copyrighted materials owned by others (including photographs, sculptures, paintings and other works of art or images published on or in websites, television, movies or other media); (vi) except for incidental usage, as determined solely by Promotion Administrator, contain or reference trademarks, logos (except Sponsor's) or trade dress owned by others, or advertise or promote any brand or product (except Sponsor's) of any kind, without permission; (vii) communicate messages or images inconsistent with the positive images and/or goodwill to which Sponsor wishes to associate; or (viii) be in violation of any law.

By submitting an Entry each entrant represents and warrants that: (i) his/her Entry is the sole and exclusive property of the entrant; (ii) the Entry is an original creation of the entrant; (iii) entrant owns all elements of the Entry; (iv) the Entry has not been copied in whole or in part from any other work; (v) the Entry does not violate or infringe any copyright, trademark/tradename, or other proprietary right of any person or entity (including but not limited to rights of privacy or publicity or portrayal in a false light); (vi) the participants depicted in the Entry (if any) have given written consent to its submission into the Promotion and use as contemplated by these Official Rules and entrant can supply proof of permission if requested by Promotion Administrator or Sponsor; (vii) entrant is the parent or legal guardian of all persons under the age of majority in the jurisdiction in which they reside who appear in the Entry (other than entrant, if applicable); (viii) the Entry has not been previously published; (ix) publication of the Entry via various media including web posting, will not infringe on the rights of any third party. Each entrant will indemnify and hold harmless, the Promotion Parties from any claims to the contrary.

BY SUBMITTING AN ENTRY, ENTRANT ACKNOWLEDGES THAT HIS/HER ENTRY MAY BE POSTED ON SPONSOR'S WEBSITES, IN SPONSOR'S DISCRETION. By entering the Promotion, you agree that your Entry is gratuitous, unsolicited and without restriction, and will not place Sponsor under any obligations other than those contained in these Official Rules, and that Sponsor is free to disclose the ideas/information contained in the Entry on a non-confidential basis to anyone or otherwise use the ideas/information therein without any compensation to you. You further acknowledge that Sponsor does not waive any rights to use similar or related ideas previously known to Sponsor, developed by its employees or obtained from sources other than you. Sponsor reserves the right to, and may or may not, monitor/screen Entries prior to posting them to the Website.

By entering the Promotion, you understand and acknowledge that you will not now or in the future be paid or compensated in any way for your Entry or for granting the Sponsor any of the rights set out in these Official Rules. You further acknowledge that Sponsor is not obligated to make use of any of the rights granted in these Official Rules.

Any waiver of any obligation hereunder by Sponsor does not constitute a general waiver of any obligation to Nominators and Heroes. Promotion Administrator and Sponsor reserve the right, in their reasonable discretion, during or upon completion of the Promotion Period, to request that any entrant resubmit his or her Entry prior to any voting or judging period.

- 6. Winner Judging: All eligible Entries will be judged by qualified judges, under the supervision of Promotion Administrator, an independent judging organization, on the basis: sincerity, inspiration and adherence to Theme (collectively the "Judging Criteria"). In the event of a tie in any round of judging, the tied entries will be re-judged by the judges using the same Judging Criteria. If there is a subsequent tie, the tie breaker will be based upon the highest score in the first Judging Criterion, continuing thereafter to each Judging Criterion in order, as needed, to break the tie. The Entry that receives the highest total score, across all Judging Criteria shall be deemed the "Grand Prize Winning Entry". The Grand Prize Winning Entry will be determined on or about August 23, 2024.
- Prizes, Approximate Retail Values ("ARV") & Odds of Winning: One (1) Grand Prize: A trip for four (4) (the Grand Prize Winning Entry Nominator and Hero, one (1) guest of the Nominator, and one (1) guest of the Hero) (the "Travelers") to the 2024 YellaWood 500 at Talladega Superspeedway to be held Sunday October 6, 2024 (the "Race"). Trip includes:
  - a. Round trip airfare for two (2) from the major airport nearest to the Nominator for the Nominator and the Nominator's guest to/from Birmingham, Alabama.
  - b. Round trip airfare for two (2) from the major airport nearest the Hero for the Hero and the Hero's guest to/from Birmingham, Alabama.
  - c. Ground transportation to/from the Birmingham, Alabama airport, the hotel, and the Race/Sponsor-related activities.
  - d. Two (2) hotel accommodation (double occupancy) for 3 days / 2 nights.
  - e. Meals for 4 people at Sponsor-related activities (such as Saturday evening reception, Sunday race, Sunday evening reception). Meals and incremental expenses outside of Sponsor-related activities will be at the expense of the Travelers.
  - f. The following at the Race: Four (4) hot laps for the Travelers, four (4) suite tickets, four (4) VIP garage tours, one (1) VIP driver introductions for the Hero, one (1) recognition of the

winning Hero as the Race Honorary Starter which involves the Hero waving the green flag to start the Race.

g. A \$10,000 donation on behalf of the Hero to a charity mutually agreed to by the Hero and the Sponsor.

Total ARV of Grand Prize is \$25,000. The Grand Prize value will be awarded and allocated for tax purposes as \$7,500 ARV to the winning Nominator and \$7,500 ARV to the winning Hero. The \$10,000 donation portion of the prize will be paid directly by Sponsor to the selected Charity approved by the Sponsor. Prizes must be accepted as awarded. All characteristics and features of the prizes except as otherwise explicitly stated above are at the Sponsor's sole and absolute discretion. Additional Prize Conditions: If, in the sole judgment of the Sponsor, air travel is not required due to a winner's proximity to the trip destination, ground transportation may be substituted for round -trip air travel, but no additional compensation will be offered. Taxes, meals, beverages, gratuities, travel upgrades, or any other expenses not specifically listed herein are the responsibility of the Travelers. Sponsor is not liable for delays, cancellation or unforeseen events related to the flights nor any harm nor loss of life which may occur during the trip. Sponsor will not replace any lost, mutilated, or stolen tickets, travel vouchers or certificates. Actual value will depend on airfare fluctuations and point of departure. Any difference between stated value and actual value will not be awarded. Winners' guests must be 18 years of age or older and must sign and return a liability/publicity release as a condition of travel. Dates of trip, location, travel arrangements and accommodations are at Sponsor's sole discretion, and are subject to availability and change. If the Race is postponed or cancelled after travel is booked, only the travel portion of prize will be awarded, and no compensation will be given for event portion of the prize. The actual value of prizes including travel will depend on point of departure and airfare fluctuations. Any difference between stated value and actual value will not be awarded. Travel dates are 10/5/2024 through 10/7/2024. Nominator and his/her quest must travel on the same itinerary and Hero and his/her quest must travel on the same itinerary. Travelers must comply with all security requirements. If Hero and/or Nominator is unable to travel on dates specified by Sponsor, the Grand Prize will be forfeited in its entirety. In such event, at Sponsor's sole discretion, an alternate winning Entry may be selected based on the results of the original judging.
- 9. Entrant Verification: In the event of a dispute regarding the identity of a Nominator or Hero, the Entry will be declared made by the natural persons in whose names the Entry was made. The Promotion Administrator reserves the right to require proof of identity and/or eligibility (in a form acceptable to the Promotion Administrator including, without limitation, government issued photo identification) for any reason the Promotion Administrator deems necessary, in its sole discretion, for the purposes of administering this Promotion in accordance with these Official Rules. Failure to provide such proof to the complete satisfaction of the Promotion Administrator within the timeline specified by the Promotion Administrator may result in disqualification of both the Nominator and Hero by the Promotion Administrator, in its sole discretion.
- 10. **Disqualification**: Entries which are incomplete, incorrect, incomprehensible, not received, or do not otherwise comply with these Official Rules (as determined by the Promotion Administrator in its sole and absolute discretion) will be void and will not be entered into the Promotion. Entries made by facsimile, overnight courier, automated means, any entry service, or in any other manner not specifically allowed under these Official Rules will not be entered into the Promotion and may result in disqualification of the Entries and the responsible entrant(s), as determined by the Promotion Administrator in its sole and absolute discretion. The Promotion Administrator reserves the right, in its

sole and absolute discretion, to disqualify any individual who tampers with or attempts to tamper with the entry process or who acts in a disruptive or unfair manner.

- 11. Notification & Validation of Winners: Potential winners will each be contacted by telephone, email, regular mail or overnight mail, and may be required to complete, sign and return an affidavit or declaration of eligibility, liability releases, background check forms, tax forms, and where lawful, a publicity release within a stated amount of time. The Sponsor may require the winning Nominator and Hero to complete and pass a background check. The return of any notification as undeliverable or failure to respond to notices or return any required documents or information in a timely manner or if a potential winning Hero does not pass a background check, if required, or a determination that a potential winning Nominator and/or Hero is ineligible or not in compliance with these Official Rules as determined by the Promotion Administrator, in its sole and absolute discretion, may result in disqualification of the winning Entry and winners and forfeiture of the corresponding prizes, and the choosing of an alternate winning Entry based on the results of the original judging.
- 12. Limitations: To the fullest extent permitted by applicable law, Promotion Parties are not responsible for: (i) electronic or digital transmissions, entries or mail that are lost, late, stolen, incomplete, illegible, damaged, garbled, destroyed, misdirected, non-delivered, or not received by Sponsor or Promotion Administrator for any reason; (ii) mail that is received postage-due; (iii) any problems or technical malfunctions, errors, omissions, interruptions, deletions, defects, delays in operation or transmission, communication failures (including but not limited to failures or malfunctions of phone lines, mail delivery service, telephone systems or other communications systems), destruction of or unauthorized access to, or alteration of, Entries, or for printing, distribution or production errors; (iv) failed or unavailable hardware, network, software or telephone transmissions; (v) damage to entrants' or any person's computer; (vi) causes beyond Promotion Parties' reasonable control that jeopardize the administration, security, fairness, integrity or proper conduct of this Promotion; (vii) incorrect or inaccurate Entry information whether caused by entrants or by any of the equipment or programming associated with or utilized in the Promotion; (viii) any typographical or other error in the printing or advertising related to the Promotion, in the administration or execution of the Promotion, or in the announcement/notification of prize winners; (ix) any human, or other error, which may occur in in the administration or execution of this Promotion; or (x) cheating or fraud by any participant.
