

**MC Hummer Giveaway
Official Rules**

**NO PURCHASE NECESSARY TO ENTER OR WIN.
A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.**

1. **Eligibility:** The MC Hummer Giveaway (the "Promotion") is open only to legal residents of the 50 United States and the District of Columbia and Canada (excluding Quebec) the "Territory") who are 18 years of age or older and located in the Territory at the time of entry. Diesel Power Gear LLC ("Sponsor"), SweepstakesPros ("Promotion Administrator") and their respective parents, subsidiaries and affiliated companies, retailers, sales representatives, dealers, distributors, licensees and the advertising, fulfillment, judging and promotion agencies involved in the development and administration of this Promotion and each of their respective officers, directors, employees and agents (collectively, "Promotion Parties"), and their immediate family members and persons living in the same households of each (whether related or not) are not eligible to participate. You may unsubscribe from these email announcements without affecting your chances of winning this Promotion. All entries become the exclusive property of the Sponsor and will not be acknowledged or returned except as provided herein. Entries which are incomplete, incorrect, incomprehensible, not received, or do not otherwise comply with these Official Rules will be void and will not be entered into the Promotion's prize drawing. Entries made by any other manner not specifically allowed under these Official Rules will not be entered into the Promotion and may result in disqualification of the responsible entrant. You are not a winner until your prize claim is validated and you receive official written notification from the Sponsor or the Promotion Administrator. In the

event of a dispute regarding the identity of the person submitting an entry, the entry will be declared made by the person in whose name entry was made.

5. **Grand Prize Drawing:** On or about July 6, 2016, the Sponsor will randomly select one (1) finalist to be the Grand Prize Winner. The process for random selection and the location of the Grand Prize Drawing shall be determined solely by the Sponsor. Further, the final date and location of the Grand Prize Drawing are subject to change at Sponsor's discretion.
6. **Prize, Approximate Retail Value ("ARV") & Odds of Winning:** One (1) Grand Prize: (Used) 1998 Hummer H-1 (ARV \$65,000) and a one-way trip for the winner to Salt Lake City, Utah to pick up the prize and meet the Diesel Power Crew.
