

**LadyBoss November Shopping Spree Sweepstakes
Official Rules**

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. PURCHASE OR PAYMENT DOES NOT IMPROVE YOUR CHANCE OF WINNING.

1. **Eligibility:** The LadyBoss November Shopping Spree Sweepstakes (the "Promotion") is open only to legal residents of the 50 United States and the District of Columbia (the "Territory") who have reached the legal age of majority in their state of residence and are located in the Territory at the time of entry. Purchase transactions involving account adjustment transactions/returns, declined credit or debit transactions, and purchases on amazon.com are not eligible for Purchase Entries.
