MyWiT® Advocate Sweepstakes 6 Official Rules

- 1. Eligibility: The MyWiT Advocate Sweepstakes 6 (the "Promotion") is open only to legal residents of the 50 United States and the District of Columbia (the "Territory") who have reached the legal age of majority in their state of residence and located in the Territory at the time of entry.
