

**SolidWorks Customer Satisfaction Survey 2017 Sweepstakes  
Official Rules**

**NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN.

1. **Eligibility:** The SolidWorks Customer Satisfaction Survey 2017 Sweepstakes (the "Promotion") is open to individuals worldwide who are 18 years of age or older (except legal residents of and individuals located in Florida, USA; New York, USA; ; Quebec, Canada; Australia; Brazil; Argentina; Czech Republic; Hong Kong; Thailand; Spain; Italy; Poland; Portugal; the Netherlands; Norway; Sweden; Russia; Turkey; Denmark; Finland; Colombia; China; Malaysia; Israel; Saudi Arabia; United Arab Emirates; Venezuela; Cuba; Iran; Sudan; Syria; and where prohibited by law).
